UNIVERSITY OF ALABAMA EARLY COLLEGE 2012 MEETING 10–11 FEBRUARY

The 2012 annual meeting of the American Musicological Society, Southern Chapter, will be held February 10–11 in the main lecture hall of Bibb Graves Hall (the Education building), on the University of Alabama campus in Tuscaloosa. LODGING

Rooms for the conference dates are reserved at two hotels. <u>Please note</u>: Bookings must be made by January 8 to be eligible for the conference rate. Be sure to mention that you are with the AMS Southern Chapter.

On campus: The Hotel Capstone, 320 West Bryant Drive, (205) 752-3200. Rooms here are very limited due to annual sports recruiting. The AMS-S rate is \$115. http://www.hotelcapstone.com

A more economical alternative is the Days Inn Suites, 1201 Skyland Blvd., Tel. (205) 759-5000, Fax (205) 759, 9864. The hotel advertizes rooms for around \$80, but no rooms are being held for conference participants.

Less expensive options may be found at websites of consolidators such as priceline.com. If you prefer to be spontaneous, the booklets of hotel coupons available at the Alabama welcome center as you enter the state contain several for Tuscaloosa hotels.

TRANSPORTATION

Both conference hotel websites provide excellent driving directions.

Birmingham-Shuttlesworth International Airport lies about 56 miles northeast of Tuscaloosa and is served by the following major airlines: American, Continental, Delta, Southwest, United Express, and US Airways.

Shuttle/limo services between the airport and Tuscaloosa are available through Executive Shuttle Network, http://www.eshuttle.net, or Birmingham Door-to-Door, http://www.birminghamdoortodoor.com. Taxis may be found throughout the day and evening on the ground level outside the baggage claim area. A number of taxi companies serve the area, with each vehicle independently owned and operated.

At the airport, rental car counters are located in the Rental Car Facility in section 1C of the parking deck for the following companies: Alamo, Avis, Budget, Dollar Thrifty, Enterprise, Hertz, and National. Cars may be picked up or dropped off in the parking deck located on the ground level.

Amtrak service between New Orleans and Atlanta unfortunately will not be available Feb. 6-9 and 13-15 due to track maintenance, and may experience delays Feb. 10-12.
