McNEESE STATE UNIVERSITY 2013 MEETING 22-23 FEBRUARY

The 2013 annual meeting of the American Musicological Society, Southern Chapter, will be held 22–23 February at McNeese State University in Lake Charles, Louisiana. Registration and paper sessions will take place in the Shearman Fine Arts Annex Theater, located on the corner of Sale and Ryan Streets. LODGING

Rooms for 21–23 February are reserved at the Wingate Hotel by Windham at 1731 W. Prien Lake Road, Lake Charles, LA 70605, www.wingatehotels.com/hotels/louisiana/lake-charles/wingate-by-wyndham-lake-charles-casino-area/hotel-overview. Call 337 502-5112 to make a reservation. Mention the AMS-South meeting to receive the conference rate of \$85 a night. Please note: Bookings must be made by January 21 to be eligible for the conference rate.

There are many other hotels in town in different price ranges, but none is within walking distance of the conference site.

TRANSPORTATION

The Wingate Hotel website provides driving directions. Parking at McNeese will be free, but attendees will need to park and then pick up a dashboard permit from the conference registration desk on the first day; permits cannot be sent in advance by email because they must be numbered. An overflow parking lot one block west of the venue on Sale Street will be available should the lot behind the Fine Arts complex be full. Campus police will forgive parking tickets received by visitors, but this requires a trip by the driver to the campus police office.

Lake Charles Airport is about 10 minutes from the University by car and is served by American Airlines and United Airlines. Lafayette Airport is 80 miles away (1-hour drive), Houston Bush and Hobby Airports 150 miles away (2.5-hour drive).

Bryan Proksch is coordinating van service between the Lake Charles Airport and the Wingate Hotel, and between the hotel and the meeting site each day. Those in need of airport pickup and dropoff are asked to send their itinerary and cell phone number to Bryan Proksch (bproksch@mcneese.edu) by 21 January so that he can make arrangements. Anyone needing daily transportation to campus should book at the Wingate.

Cars may be rented at Lake Charles Airport through Avis, Budget, Enterprise, Hertz, or National.
