ABOUT OUR NEW OFFICER AND REPRESENTATIVE

Valerie Goertzen (President) is Associate Professor of Music History at Loyola University New Orleans, where she holds the Edward J. Kvet Distinguished Professorship of Music and Fine Arts. She earned the M.Mus. and Ph.D. in musicology at the University of Illinois and has received research grants from the Fulbright Foundation, Deutscher Akademischer Austausch Dienst, and National Endowment for the Humanities. She is a member of the advisory board of the new Brahms collected edition (*Johannes Brahms Gesamtausgabe*) and has edited a volume in that series containing Brahms's arrangements for piano, four hands, and two pianos of works of other composers (Munich: G. Henle, 2012). She is working now on a companion volume of arrangements for piano solo. Goertzen has published and presented papers on topics relating to Brahms, on improvisation by pianists in the eighteenth and nineteenth centuries, and on the programs of Clara Schumann. She is on the Board of Directors of the American Brahms Society and co-edits the Society's Newsletter with fellow Loyola faculty member William Horne. She has served as AMS Council Representative, a member of the AMS Committee on Career-Related Issues, and Secretary-Treasurer of the Southern Chapter.

Michael Vincent (Student Representative) is a doctoral fellow in musicology at the University of Florida. Before moving to Florida, he was an adjunct instructor at Bowling Green State University in Ohio, where he taught music history, and Owens Community College, where he taught applied guitar and directed the guitar ensemble. He served as president of the University of Florida Student Society for Musicology and is serving in the American Musicological Society's Committee on Career-Related Issues. His paper "Continuous Expositions and Static Harmonic Modules in Boccherini's Sonata Forms" is forthcoming in *Boccherini Studies*. Michael's primary research interests are the music of Luigi Boccherini and sonata theory.
