### LOYOLA UNIVERSITY NEW ORLEANS FEBRUARY 27–28

The 2015 annual meeting of the Southern Chapter of the American Musicological will be held February 27–28, at Loyola University, 6363 St. Charles Avenue in uptown New Orleans. We will meet in the newly renovated Nunemaker Hall on the third floor of Monroe Hall, near the corner of Calhoun Street and St. Charles Avenue and directly behind the Communications and Music Building. Everyone is welcome.

### LODGING

The block of rooms for Thursday and Friday nights, February 26 and 27, at the Hampton Inn-Garden District, 3626 St. Charles Avenue, is being held only **until January 26**, so please act soon. The hotel is about 2 <sup>1</sup>/<sub>2</sub> miles from Loyola and directly on the streetcar line. Rooms (two double beds or a king bed and sofa sleeper, 1–4 people) are \$149 plus taxes and fees. Reserve by phone at 504 899-9990 (American Musicological Society, Southern Chapter group rate) or at <u>http://www.neworleansstcharlesave.hamptoninn.com</u> (group code "AMS"). Please note: Bookings must be made by January 26 to be eligible for the conference rate. Further information about lodging is posted on the chapter website.

### **GETTING THERE**

The Louis Armstrong New Orleans International Airport (MSY) is served by major and smaller airlines. Airport Shuttle New Orleans runs vans between the airport and downtown and uptown sites for \$20 one way, \$38 round trip (<u>http://www.airportshuttleneworleans.com</u>, 504 522-3500). Ticket desks are on the lower level across from baggage claim. Taxi fare is \$33 one way for one or two persons and \$14 for each additional passenger. There is a new car rental facility, located in a separate building through the door near baggage claim 14. Loyola faculty members may be able to arrange pickup from the airport. Please post inquiries on the GoogleDocs spreadsheet or contact Valerie Goertzen at <u>goertzen@loyno.edu</u>. Members may also want to

consider using the airports in Gulfport or Baton Rouge and coordinating ground transportation with a colleague who is driving to New Orleans.

The streetcar ride from the Hampton Inn to Loyola takes about 13 minutes and costs \$1.25 cash (40 cents for seniors 65+ with ID). A one-day pass can be purchased from the driver for \$3.00 cash. Cars pass about every 10 minutes, except between 1:00 a.m. and 6:00 a.m. when the scheduled interval is about 20 minutes. The ride from the French Quarter (Canal at Carondelet) to Loyola takes about half an hour (for schedules see <u>www.norta.com</u>). Parking passes for Loyola's West Road Parking Garage, a short walk from the conference venue, will be available at the registration table. Parking is permitted on the street, but take care that the area is not marked as having a two-hour limit. Be sure to leave the required 4 feet to a driveway, 15 feet to an intersection.

### INFORMATION FOR STUDENT MEMBERS Student Paper Award

Students whose papers have been accepted for the AMS-S program may apply to receive the Student Paper Award of \$250 by following these guidelines:

1. To be eligible for the student paper award, a student must be enrolled in a graduate music program, must not have completed the Ph.D., and must be a current member of both the national AMS and the Southern Chapter. *Note:* to be eligible the student must be a *student* member of the AMS (not a "regular" member).

2. Before being considered for the award, student papers must be accepted for presentation at the Chapter meeting through the normal review process. The student whose paper is accepted must attend the Chapter meeting and present the paper.

3. A copy of the complete paper, including handouts, must be received by the President, Valerie Goertzen, via email at <u>goertzen@loyno.edu</u>, by Thursday, February 12, 6 p.m. (EST). Powerpoint slides, if deemed integral to the presentation, may be emailed as well. If the Powerpoint slides are too large for email, the student will be responsible for setting up a download via some method (Dropbox, Google Documents, etc.) and informing the President when they are available.

4. The award is \$250 cash. The winner will be announced at the business meeting or (if the competition extends into Saturday morning) immediately after the meeting. In addition, the winner will be acknowledged in the March AMS-S Newsletter.

5. The committee reserves the right to refrain from making an award if the members deem no student paper worthy. A student who wins the award is ineligible to receive the award again in the year immediately following.

# Help with travel to New Orleans

Our chapter contributes \$50 to students presenting papers at our chapter meeting, with a maximum of \$150 per institution. Recipients must be student members in good standing of both the AMS and Southern Chapter and must not be receiving travel funds from their institution. Further details about eligibility and procedures were included in the March 2011 issue of the Newsletter (available online). The Secretary-Treasurer typically reimburses a faculty representative from the institution, who then distributes the funds.

# CALL FOR NOMINATIONS

Elections for the offices of President-Elect, Secretary-Treasurer, Abstracts Editor, and Student Representative to the AMS Council will take place at the New Orleans meeting. Please contact Alice Clark, chair of the nominating committee, at <u>avclark@loyno.edu</u>, with your nominations. Nominees must be chapter members in good standing, and only chapter members who attend the meeting are eligible to vote. Nominations for student representative must come only from faculty members from the nominated student's institution (bylaws article V-E, available on the chapter website). According to the established rotation, this year's representative will be chosen from among students at Florida State University.

# DUES

Annual dues for the AMS-S chapter are \$10 for regular members and \$5 for students. Dues for 2015 should be paid in person at the New Orleans meeting. Those not attending the conference will need to send their checks to the newly elected Secretary-Treasurer. Mailing information will be included in the March newsletter.
