### **About Our New Officers and Representatives**

**Sarah Provost** (President-Elect) is an associate professor of musicology at the University of North Florida. She specializes in jazz of the 1930s and 1940s, including topics in gender, creativity, and historiography. Her publications include essays in *Music and the Moving Image*, *Jazz Perspectives*, *Jazz and Culture*, and several forthcoming works in edited collections.

Blake Howe (Secretary—Treasurer) is Paula G. Manship Associate Professor of Musicology at Louisiana State University. His research interests include Franz Schubert, film music, and Disability Studies, and his writings on these and other topics have appeared in the *Journal of the American Musicological Society*, *The Journal of Musicology*, *Nineteenth-Century Music Review*, *The Musical Quarterly*, *Music Research Annual*, and the *Journal of Music History Pedagogy*. He is the former co-chair of the Music and Disability Study Group of the American Musicological Society and the former recording reviews editor of *Nineteenth-Century Music Review*.

Laura Dallman (Abstracts Editor) is a musicologist who focuses on orchestral music and performance in the 20th and 21st centuries. Her research addresses issues of accessibility, particularly as they relate to symphonic sound and attitudes of access within symphonic institutions. Laura received a Bachelor of Music in piano from Ball State University (2007) and both a Master of Arts and a Doctor of Philosophy in musicology from Indiana University (2009, 2017). She has presented her research at conferences in the United States, Ireland, England, and Wales. Her recent book chapter in *Twentieth- and Twenty-First-Century Song Cycles* analyzes the musical language of Jennifer Higdon's *Civil Words*.

Emily Eubanks (Student Representative to AMS Council) is a second-year doctoral student at Florida State University. Before beginning her Ph.D., Emily completed a master's degree in Historical Musicology at FSU and a master's degree in Flute Performance at Oklahoma City University. For her master's thesis, Emily examined the managerial work of Blanche Wetherill Walton on behalf of modernist musicians in the 1920s and 1930s. Her dissertation will focus on musical salon culture of Biedermeier Vienna. Emily is currently serving as President for FSU's Society for Musicology, teaching undergraduate courses in musicology, and directing FSU's Renaissance Instrumental Ensemble, Collegium Musicum.

Christy Thomas Adams (Webmaster) joined the musicology faculty at the University of Alabama School of Music in 2019, having previously held faculty positions at the Yale School of Music, Bowdoin College, and Bates College. She received her Ph.D. with distinction in Music History from Yale University. Her broad research interests include the history and theory of opera, reception studies, cultural history, the history of media technologies, and the theoretical and conceptual issues of performance and mediation. Aside from her research and teaching, she also maintains an active presence as a classically trained soprano. As the incoming webmaster for AMS-S, she is pleased to share her skills with current—and not merely historical—technologies with the chapter.
