# **Vehicle Travel and Conference Parking**

By air, Baton Rouge is served by Baton Rouge Metropolitan Airport (code BTR; 10 miles from campus) and New Orleans International Airport (code MSY; 75 miles from campus).

If you will be driving to the conference venue from your hotel, keep in mind that you will probably need to pay for your parking spot when you arrive to campus. Budget about \$15 for the meter on Friday, February 23. Review the information on <u>Visitor Parking Permits</u> at the website of LSU's Parking & Transportation Services.

# Lodging

Located 0.5 miles from the conference venue (about 10 minutes by foot), The Cook Hotel at LSU is the closest lodging option; a block of rooms has been set aside at a conference rate (225-383-2665; \$139/night + tax, use this link and book by Jan. 24). It's all purple, all gold, all the time at the Cook; if "complimentary breakfast at the Shaquille O'Neal Lodge" is on your bucket list, this is the place for you. Further away (1.2 miles; about 25 minutes by foot), and a bit more subdued, are the Sonesta ES Suites – University at Southgate (225-456-5430; \$205/night + tax).

Options within driving distance to campus include the <u>Courtyard Marriot at Acadian Center</u> (225-924-6400; \$143/night + tax); the cluster of budget hotels near the College Drive exit on I-10, including <u>Comfort Inn - University Area</u> (225-590-5186; \$101/night + tax); and the swanky hotels in downtown Baton Rouge, including the <u>Hotel Indigo</u> (225-343-1515; \$151/night + tax).

# **Student Paper Awards**

Students whose papers have been accepted for inclusion in the AMS-S program may apply to receive a Student Paper Award of \$250 by following these guidelines:

- 1. To be eligible for a student paper award, a student must be enrolled in an undergraduate or graduate music program, and graduate students must not have completed the Ph.D. Students must be current members of both the national AMS and the Southern Chapter. Note: to be eligible, students must be student members of the AMS (not "regular" members).
- 2. Before being considered for an award, student papers must be accepted for presentation at the chapter meeting through the normal review process. Students whose papers are accepted must attend the chapter meeting and present the paper in order to receive a prize.
- 3. A copy of the complete paper, including handouts, must be received via email by Chapter President Sarah Caissie Provost (<a href="mailto:sprovost@hartford.edu">sprovost@hartford.edu</a>) by Friday, February 16, 2024 at 6 pm (EST). Slideshow files and audio/video files, if essential to the presentation, must be shared via Dropbox with <a href="mailto:sprovost@hartford.edu">sprovost@hartford.edu</a> prior to the submission deadline.
- 4. Two Student Awards, consisting of \$250 each, will be awarded. The winners will be announced at the business meeting or, if student presentations extend into Saturday morning, immediately after the chapter meeting. The winners will be acknowledged in the March AMS-S newsletter and recognized by the national organization on its website.
- 5. The committee reserves the right to refrain from making an award if the members deem no student paper worthy. A student who wins the award is ineligible to receive the award again in the year immediately following.

### **Travel Assistance for Student Members**

AMS-S allots a maximum of \$600 per year to reimburse travel costs of students presenting papers at our chapter meetings. These funds will be divided regardless of students' institutional affiliations. No student will receive more than \$100 per year, and AMS will only reimburse expenses not covered by a student's home institution. If you plan on receiving a reimbursement, please keep your receipts. After the meeting, fill out the <a href="AMS's Payment Request Form">AMS's Payment Request Form</a>. Be sure to indicate that the funds are supposed to come out of the Southern Chapter's account.

No application is necessary; the Chapter Secretary-Treasurer will verify student eligibility with a faculty member from each institution and then disburse the funds to students after the meeting. Elections for the offices of AMS Council Student Representative will take place at the 2024 meeting. Nominations for Student Representative must come only from faculty members from the nominated student's institution (per Bylaws Article V. §E., available on the <u>chapter website</u>). According to the established rotation, this year's representative will be chosen from the student

members of Florida State University.

#### **Dues**

Annual dues for the Southern Chapter are \$10 for regular members and \$5 for students. Dues for 2024 should be paid at the 2024 meeting in Baton Rouge. There are three ways to do so. Bach's St. Matthew Passion: The Choreographic Vision of John Neumeier," *BACH: Journal of the Riemenschneider Bach Institute* 54 (2023): 171–211; and one chapter in *Joseph Joachims Identitäten*, ed. Katharina Uhde (Hildesheim: Olms, 2024). He has also presented papers at the Boston University Center for Beethoven Research; Sounding Habsburg Conference at Bohemian National Hall, N.Y.C.; U-Mass.-Amherst Bach Symposium; and Schubert Research Center, Vienna.

Matthew Wood, Ph.D. candidate in musicology at LSU, presented papers on Franz Liszt and Félicité Lamennais at several conferences in the 2023 calendar year: the Consortium on the Revolution Era, the Allegheny chapter meeting of the AMS, the Southwest chapter meeting of the AMS, and the Historical Graduate Students Association Conference at LSU. He taught as interim professor of piano at the University of West Florida in the spring 2023 semester, putting to further use his previously-granted DMA in piano performance. Matt likewise completed a circuit of job interviews and was offered positions in academia, church music, and pre-college teaching in California, Michigan, Texas, Louisiana, and Florida; he has recently settled into a joint appointment in Berkeley, California, where he continues his dissertation research while working in the field.
